Motion #2024-06: Proposal for scholarships for the 2024 Post-Conference and Fall 2024 Assemblies for GSRs whose groups cannot afford these expenses

- **Dates/Location:**
 - Post-Conference Assembly – May 18-19, 2024 Fresno
 - Fall Assembly (“Mini-PRAASA”) – October 19-20 in Angels Camp

- **Benefits:**
 - GSRs are voting members at Assemblies and help decide matters for Area 07. More District 21 participation equals increased input on Area issues, which ultimately impact groups.
 - Increased engagement of GSRs results in increased knowledge about group processes and increased commitment to our primary purpose through the legacy of service.
 - GSRs bring valuable group input to the Area through Assemblies and bring back equally valuable feedback.

- **Cost: Total increase to 2024 Proposed Spending Plan includes transportation/mileage (with carpooling strongly encouraged), ½ lodging and registration fees. Scholarship recipients are responsible for any costs over this amount (ex: can’t find a roommate, meals, etc.)**

*Mileage cost may be less as carpooling is strongly encouraged, or public transport such as train could be feasible. Transportation costs could be slightly higher as costs such as parking and bridge tolls are also allowable. If members carpool, each can claim their portion but the full payment will go to the member whose car was driven.

Motion #2024-07: Proposal to Fund District 21 H&I Representative to Joint Northern/Southern California H&I Conference

- **Dates:** Friday, May 3 - Sunday, May 5
- **Location:** Doubletree Hotel, 3100 Camino de Rio Ct., Bakersfield
- **Benefits:**
 - Meet, interact with and teach and learn from H&I representatives from other Districts and Areas in California. The joint meeting is the first ever all-CA event
 - Increase knowledge H&I processes and resources, and bring information back to the District and Groups about how we can best support our Primary Purpose through H&I
- **Cost: Estimated but not to exceed \$575.00**
 - Up to \$406 – Mileage 608 mi. RT (parking, bridge tolls or train fare/BART or other reasonable transportation also allowable) – if shared mileage, the H&I Rep's portion will go to the driver.
 - \$30 - Registration
 - \$133.50 (½ of 2 nights hotel)
 - Recipients understand they must cover any other (ex: meals, etc.)

Motion #2024-08: Approve the District 21 Spending Plan for 2024

Background: The Proposed Spending Plan for 2024 was endorsed by the District 21 members in December 2023. The updated Proposed Plan includes:

- **Equipment purchase (District laptop to support hybrid meetings)**
- **Slight increase in DCM and Alt DCM travel expense**
- **Elimination of funding for BTG Rep to attend conference (position is vacant)**
- **Changes in funding for events**
- **Significant increases to provide scholarships for GSRs to attend PRAASA and 2024 Assemblies.**

These items were discussed at the February D21 Business Meeting.

Also note that the PICPC Chair has requested a significant increase for materials for 2024, which will be discussed as part of the Spending Plan approval process.
